

The administrator of personal data is REB Properties Sp. z o.o. with its registered office in Warsaw (00-113), 53 Emilii Plater St., XXIII floor, entered into the Entrepreneurs Register of the National Court Register maintained by the District Court in Opole, VIII Commercial Division of the National Court Register under KRS number 0000565584 ('Administrator')

**The Administrator collects data resulting from the activity of website users, in particular information about the device and the fact of signing in, date, time of visit and range of content viewed as well as the IP address of the device from which the connection was made, frequency of using the website.**

**The personal data of website users are processed for the purposes:**

- necessary to use the website;
- of presenting and implementing our services;
- of interest in operation of companies belonging to the Reb Group;
- allowing potential investors to contact the Reb Group;
- statistical;
- for the technical administration and ensuring data security needs;
- of saving cookies and collecting data from the website;
- of implementation of the legitimate interest of the company, i.e. archiving of data, possible defense against claims and pursuing rights of its rights;
- of data processing for marketing purposes.

**The rights of the person whose personal data is processed.**

- the right to access personal data and rectification if this information is inconsistent with the actual state, deletion and processing restrictions of the personal data;
- the right to object to the processing of personal data;
- in the field of the processing of personal data takes place on the basis of the granted consent, the right to withdraw consent is guaranteed, which will not affect the lawfulness of data processing which was made on the basis of consent before withdrawal;
- in the field of which the personal data is processed in order to conclude or perform the contract or are processed on the basis of a prior consent – the person concerned by this data has the right to transfer the personal data;
- the right to be forgotten, i.e. requests from the Administrator to immediately delete personal data, if the data is no longer necessary for the purposes for which it was collected or otherwise processed, or the consent for processing has been withdrawn and there is no other legal basis for processing, or an objection has been raised, or personal data was processed unlawfully, or personal data must be removed in order to comply with a legal obligation under European Union law or law of the country to which the Administrator belongs or personal data has been collected in connection with the provisions of information society services.

Personal data will not be transferred to third countries outside the European Economic Area.

If the processing of personal data will be considered as a violation of the RODO regulations – the entitled person has a right to file a complaint to the supervisory body taking care of protection of personal data, which is currently ‘Generalny Inspektor Ochory Danych Osobowych’ in Poland.

Access to personal data will have employees of the company and entities cooperating with the company, providing IT, financial or legal services on the basis of the authorization granted for this purpose to process personal data.

Personal data will be stored in accordance with applicable law only for a period necessary to achieve the purposes for which it was collected, provided that one of the prerequisites for the processing of personal data in current.
